Q :

- During the presentation of the debt you mentioned that you proposed a pre-budget consultation but didn't get the majority of vote for. Could you tell us who voted against it?

A :

- It was not a formal vote yes, but a decision was made together at the time to not do it.
- I don't want to put anyone to the spotlight. The next council can look at that option.

Q :

- Regarding 7 n) of the agenda, what would be the impact on existing roads?

- Combien a coûté les frais d'avocat pour la défense de la demande d'injonction au sujet du sentier communautaire et d'où proviennent les fonds?

A :

- Cost to defend is 12,000\$ to date but our Finance Director estimated the total cost will be around 25,000\$. On cherche les façons de payer dans l'argent qui reste en fin d'année, comme ce n'était pas prévu. Ce ne sera pas ajouté à la dette mais pris dans le budget des opérations.

Q :

- What is the status of the environmental studies of the community trail?
- I think it's a mistake to wait for this and also the design charrette because of all the misinformation.

A :

- The report is not finalised yet. The final report will be present to the public once is done and not only put on the website. This council will leave it to the next.
- This council planned to proceed with the charrette but because of legal matters, it would happen with the new council.

Q :

- Regarding the letter to the MTMDET, the goal of the community trail was to keep it local but what if it's connect to Gatineau?

A :

- The connection was in the transportation masterplan. Lots of residents wants that connection. The overall approach is to allow the passing to college for students, back and forth. It would still be rustic and local.
