## A Word from the Mayor

Dear residents,

Fall is in full swing, and we are slowly sliding into the cold weather of winter. I hope that you enjoyed the beauty of nature once again this year.

As we do every fall, the Municipality has begun the budget process. The Three-Year Capital Plan (PTI) for the next three years was adopted at the November Council meeting. This is an important step as we had to make decisions on which projects to prioritize to address our needs while keeping an eye on our ability to pay. Work is also well underway on the budget, which will be adopted in mid-December at a special meeting.

Over the past few weeks, Council has completed updates to the Master Plan and has adopted its final version. Now that this is done, the zoning, subdivision and master plan by-laws have been submitted to MRC des Collines-de-l'Outaouais for approval. The PIIA, PPCMOI, construction, and permit and certificate by-laws have already been approved by the MRC. If all goes according to plan, the new by-laws will come into effect this winter. Once again, I would like to thank the population for their participation during this process and congratulate the employees of the Urban Planning Department for their exceptional work. They worked hard for three years to craft a new Master Plan that reflects the values and concerns of Chelsea residents.

On another note, September saw a few cultural activities, including Artistic Awakening in the Parks and the artists' studio tour. On October 16, close to 500 people participated in the Great Chelsea Walk. It was a pleasure to walk with you and to see how important healthy lifestyles are for the population of Chelsea. Our next big recreational event will be the Magical Christmas weekend on December 3<sup>rd</sup> and 4<sup>th</sup>.





The Municipality launched its Voie Verte Chelsea Code of Conduct awareness campaign in August. In place since 2018, it was updated and officially adopted by Council in February 2021. Designed by residents and trail users, it promotes courtesy, safety, and respect for other users and adjacent landowners.

# Chelsea mobilizes for safety around elementary schools

This fall, Société de l'assurance automobile du Québec (SAAQ) is launching a new awareness campaign on speeding. It has been developed in partnership with the Municipality of Chelsea, the MRC des Collines-de-l'Outaouais police department, École de Grand-Boisé School and Chelsea Elementary School to remind drivers in Chelsea to obey speed limits in school zones including:

- on Chemin d'Old Chelsea
- on Chemin Scott

Whether on foot, skateboard, or bike, many children and adults travel in school zones. Road signs and traffic signals instruct road users to exercise caution and respect speed limits to avoid accidents and collisions. School routes aim to ensure the safety of the students attending school throughout the year.

### Why slow down?

Did you know that when you drive faster, your field of vision decreases? The human brain can only process a limited amount of information at a time. In addition, speed increases braking distance.

Did you also know that driving more slowly greatly increases your chances of surviving a collision and reduces your potential to be seriously injured? The survival rate of an impact between a vehicle and a pedestrian goes from 90% at 30 km/h to only 25% at 50 km/h.

In conclusion, slowing down and taking a few extra minutes to get where you're going increases not only your own safety, but the safety of everyone.

## Don't interfere with snow removal!

During the winter season, your cooperation is essential to facilitate snow removal.

- It is forbidden to deposit or throw snow or ice on a public road, even when clearing your driveway.
- No vehicles may be parked on the roadside during a snowstorm.
- Parking on public roads is banned between midnight and 7 a.m. from November 15 to April 1 inclusively.
- Remember to place your bins in your driveway and not on the street so that they do not interfere with snow removal operations.
- Avoid building snow castles, tunnels or forts near roads.

## Final phase of Master Plan review process plan

The Master Plan review process is coming to an end as all the by-laws subject to the review have been adopted in their final form. The final by-laws adopted by Council at the Special Meeting of August 31, 2022 and the Regular Meeting of October 4, 2022 are as follows:

- Construction by-law (1217-22)
- Site planning and architectural integration programs by-law (1218-22)
- Permits and certificates by-law (1219-22)
- Special building construction, modification, or occupancy projects by-law (1220-22)
- Minor exemptions by-law (1221-22)
- Master plan by-law (1214-22)
- Zoning by-law (1215-22)
- Subdivision by-law (1216-22)

The review of Chelsea's Master Plan was carried out over a period of nearly three years and was the subject of a major public consultation process launched in 2020, consisting of online questionnaires, workshops, and preliminary online public consultations. In addition, a dozen briefs were submitted by community organizations, stakeholders, and citizen associations. Public consultations were held before by-laws were drafted to identify issues of importance to you.

In 2022 formal public consultations under the Act respecting land use planning and development were held on May 18 at the Farm Point Community Centre, May 19 at the Hollow Glen Community Centre, and June 13 and 14 at the Meredith Centre.

This comprehensive process allowed us to consult with residents, community groups, merchants, and members of our municipal committees on issues that affect the future of Chelsea. All bylaws were revised to reflect the comments and recommendations received during the public consultations. These have allowed for the addition of various provisions regarding tree planting and removal, environmental protection, protection of our wetlands and waterways, and increasing the size of parental dwellings to 90 m<sup>2</sup>.

Now that they have been adopted and the process of requesting a referendum vote for the zoning and subdivision by-laws has been completed, all the by-laws have been submitted to the MRC des Collines-de-l'Outaouais for approval and will come into effect in the winter of 2022–2023.

We would like to thank all residents who participated in any steps in the review process. Your contribution has made it possible to create an urban plan that gives the Municipality the means and capacity to protect our environment, offer affordable and multi-generational housing, integrate essential basic services into our urban perimeters, and foster human-scale development in keeping with the rural character of our municipality.

## Municipal Council adopts 2023–2025 Three-Year Capital Expenditure Plan

Municipal Council adopted its Three-Year Capital Plan (PTI) for 2023 to 2025 at a extraordinary meeting held on November 1<sup>st</sup>. The PTI includes investments of \$54 million allocated over three years as follows:

- · 2023: \$25M
- 2024: \$7.5M
- 2025: \$21M

The PTI covers the various projects that the municipality plans to carry out within the next three years, including scheduling and financing through various revenue streams. It represents Municipal Council's intentions for capital investments. Depending on the prices obtained during the call for tenders process, some projects may be subject to change.

## MAJOR INVESTMENTS IN THE FARM POINT SECTOR

The Farm Point sector will benefit from major investments, including the purchase of land from the Déry quarry (\$6.3M), the rehabilitation of Chemin de la Rivière (\$7.5M) as well as the redevelopment of Farm Point Park, including renovations to the community center (\$378K).

These investments will not only improve existing infrastructure, but also address a variety of municipal needs. The acquisition of land from the Déry Quarry will allow for the creation of affordable social housing and the conservation of high ecological value areas.

The other projects in the PTI mainly concern

infrastructure and buildings. Necessary work includes the expansion of the water and wastewater plants, as well as upgrades to the wastewater plant, some municipal buildings, and repairs on Chemin du Lac-Meech. These projects alone represent an investment of \$19 million.

Other major projects under the PTI, spread over three years, include:

- Redevelopment of the New Chelsea sector located on Route 105 north of chemin d'Old Chelsea: \$3.8M
- Development of a community access to the river: \$90K
- Purchase of a ladder truck and replacement of a fire truck: \$2.9M
- Various works on Voie Verte Chelsea: \$1.5M (including a \$347K grant)
- Purchase of emergency generators: 1,3 M\$
- Construction of a skatepark and pumptrack: \$420K

"The Municipal Council has adopted a Three-Year Capital Plan that will improve the existing infrastructure and meet the municipal needs. Investments in the plants, our municipal roads and the fire department are costly, but necessary for the safety of our residents. In addition, investments in community access to the river, active mobility and recreation will contribute to healthy lifestyles and enjoyment of our environment. I am proud of the work that has been done to prioritize, while maintaining a balance between our ability to pay and our needs. " - Pierre Guénard, Mayor.






# 45 new trees and shrubs on chemin d'Old Chelsea

The Municipality of Chelsea recently planted trees and shrubs along Chemin d'Old Chelsea and a portion of Route 105. This project was undertaken to increase tree cover in the Centre-Village and enjoy the many benefits that trees offer in an urban setting. As the effects of climate change are increasingly felt, this greening of Chelsea's downtown area will help counteract heat islands and reduce water runoff. All told, 45 trees and shrubs have been planted on participating private properties and at businesses.



## **November: Radon Awareness Month**



The Municipality wishes to remind its residents that this is a good time to test for radon in the air. When the outside temperature drops, radon can accumulate in higher concentrations in enclosed and less ventilated areas, such as the lowest rooms in your home.

#### WHAT IS RADON?

Radon is a naturally occurring radioactive gas that comes from the decay of uranium in the earth's crust. It is therefore present in the soil and is released into the atmosphere where it mixes with fresh air and can infiltrate an enclosed space, such as a home. Since radon has no odor, no color and no taste, the only way to detect it is through a measurement test.

#### **RECOMMENDATIONS**

We recommend that you test the air on all floors of the house where a person spends an average of 4 hours per day during the heating season (November to April). Be sure to use long-term (3 months) testing devices as recommended by Health Canada.

#### WHERE CAN I BUY TEST KITS?

Test kits are available at City Hall for \$27 for a radon air test and \$75 for a radon water test (taxes included). You can also find them at some hardware stores.

## H<sub>2</sub>O Program: test your well water quality

H<sub>2</sub>O Chelsea is a program offered to residents who wish to test their well water quality at competitive prices. Fall is one of the best times to do this. Water sampling kits are available at Town Hall to determine whether or not there is a problem with your well water. Once the sample is collected, return the bottles to the Municipality and they will be sent to the laboratory. You will receive the results by email in a week or less, depending on the severity of the situation. For more details, visit



## **Cloth Diaper Incentive Program**

If you use new or second-hand cloth diapers, you may be eligible for the incentive. Through the Green Fund, the Municipality offers a reimbursement of up to 50% of the invoice (with proof of purchase), to families who use cloth diapers, in order to encourage the use of this alternative on a temporary or permanent basis. This pilot project ends on December 31, 2022 or until the budget is exhausted.

## The first person in charge is you!

The week of October 9 to 15 was Fire Prevention Week across the province. Your fire department would like to remind you of the safe behaviours to adopt in order to be well prepared in case of fire. Here are a few of them:

- Install a smoke alarm on each floor, including the basement;
- Keep a constant eye on cooking food and use a timer:
- Prepare and practice an escape plan;
- Never use accelerants to fuel the fire.

## Tips for reducing the risk of wildfires



In Chelsea, it's always good to be reminded of good practices when living in or near the forest. Here are some tips and tricks to improve your property's protection against fire according to the PareFEU guide, created by the Ministère des Forêts, de la Faune et des Parcs.

## **Controlling vegetation**

The judicious management of your property is an asset in preventing or fighting forest fires. Two perimeters must be created around your home: the firebreak zone and the mitigation zone. To facilitate the work of firefighters in the event of an emergency, remove materials that could easily catch fire around your home (trees, hay, wooden materials, etc.).

### Remove forest debris

When working outdoors, remember to:

- Burn wood according to municipal regulations and the SOPFEU risk index in effect;
- Recover the wood as construction material or firewood;
- · Shred branches to make mulch;
- Compost small debris such as leaves, branches, wood chips and grass;
- Drop off your branches at the annual municipal collection (October 15, 2022).



### Landscape the building

Tidy up the area around and inside your home:

- Remove dead leaves and branches from gutters, your roof surface and porch;
- When renovating your home, use less flammable materials;
- Have your chimney swept once a year;
- Notify Hydro-Quebec if branches or a tree are leaning on the electrical network wires;
- Store your firewood more than 10 meters away from any building.

## **Equip yourself to act**

The appropriate equipment to control a fire in your home is:

- A garden hose of sufficient length;
- A ladder to access the roof:
- Sprinklers to water the lawn or building;
- A 200-litre water tank placed nearby.






## A GREAT SEASON FOR CIEC YOUTH!



The Splendid and the Vile, Erik Larson



Book of the month

On Winston Churchill's first day as prime minister, Adolf Hitler invaded Holland and Belgium. Poland and Czechoslovakia had already fallen, and the Dunkirk evacuation was just two weeks away. For the next twelve months, Hitler would wage a relentless bombing campaign, killing 45,000 Britons.

It was up to Churchill to hold his country together and persuade President Franklin Roosevelt that Britain was a worthy ally—and willing to fight to the end.

In The Splendid and the Vile, Erik Larson shows, in cinematic detail, how Churchill taught the British people "the art of being fearless." It is a story of political brinkmanship, but it's also an intimate domestic drama, set against the backdrop of Churchill's primeministerial country home, Chequers.

The Splendid and the Vile takes readers out of today's political dysfunction and back to a time of true leadership, when, in the face of unrelenting horror, Churchill's eloquence, courage, and perseverance bound a country, and a family, together.






