




2025-2029 Capital Expenditure Program

These pillars are the basis for adoption of the 2025-2029 Capital Expenditure Program.

Wastewater and drinking water plants

A massive \$12.9M investment for the wastewater and drinking water plant.

Following the adoption of a two-year moratorium, the continuation of this modernization work is essential over the next few years to ensure the future development of the Municipality.

WASTEWATER PLANT: \$12.4M

- \$754K has been earmarked in 2025 for professional services related to the wastewater plant expansion.
- An \$11.6M investment would make it possible to dehydrate sludge through the installation of a centrifuge, thereby reducing the frequency and volume of sludge removal.

DRINKING WATER PLANT: \$546K

• A sum of **\$546K** is earmarked in 2025 for professional services related to the expansion of the drinking water plant.

This project is conditional on receiving funding.

Vehicles, equipement and public safety

\$1.2 million is earmarked for the purchase and replacement of equipment essential to the maintenance of our infrastructure and the safety of our employees.

PURCHASE AND REPLACEMENT OF MISCELLANEOUS EQUIPMENT: \$1.1M

 This includes the replacement or purchase of vehicles required for routine operations and the purchase of equipment for the Fire Department.

PURCHASE AND INSTALLATION OF GENERATOR: \$50K

• Efforts to protect the population in the event of service disruptions continue. In 2025, an amount has been earmarked to begin the project to install a generator at the Meredith Centre, to ensure that an Emergency Reception Centre is fully operational in case of an emergency or power failure.



The project will be completed in 2026.

Community access to the river

\$200K investment to develop community accesses to the Gatineau River.

Following the *Société de sauvetage Québec*'s recommendations on the types of river access development that could be envisaged in Farm Point and on ch. Burnett, sites previously identified, **\$200K** is currently earmarked for Phase I of the development of these accesses, including professional services and implementation phases.

Further phases are planned from 2026 to 2029.

\$1.9M in new parks and trails.

PARKS: \$670K

• This amount will be used for Phase I of a future teen park*, as well as to upgrade certain parks, such as a shade structure at the Ruisseau Chelsea Park.

TRAIL DEVELOPMENT: \$293K

- Various improvement work is planned for the trail west of Autoroute 5.*
- · Work will begin on a trail dedicated to the Farm Point seniors' residence.

VARIETY OF WORK ON VOIE VERTE CHELSEA: \$934K

• This includes the construction and stabilization of the Vallée sector, signage, the addition of bollards and chicanes, and the development of an interpretive site* for the old train station and the Chelsea Elementary School boat.

\$3.6M to maintain and improve the safety of our roads.

PURCHASE AND INSTALLATION OF SPEED CALMING DEVICES: \$435K

- This includes the purchase of radar speed signs and illuminated pedestrian crossing signs.
- Start of speed measurement project on route 105.
- Work begins on the school corridor at École Grand-Boisé.

REPAIR OF CHEMIN DE LA RIVIÈRE: \$500K

• The road rehabilitation is complete. This amount includes expenses required to complete the project.

MISCELLANEOUS STABILIZATION WORK, CULVERT REDEVELOPMENT AND REPLACEMENT: \$1.1M

 Culvert stabilization and replacement work is planned on Route 105 and on various roads and trails.

ROAD REHABILITATION: \$1.6M

- Chemin Notch rehabilitation project begins. The project will take four years to complete.
